The prosecution under section 148/149/353/186/324/436/427/295 / A295 / TP Subsection i.h.g.d 7ATA is written that in case no. 1258/23 dated 16.08.23 under section 295-B / 295-C mentioned culprits in the police station of city of Jaranwala. (1) Raja Amir Masih (2) Raki Masih sons of Salim Masih residents of Christian did desecration of the Holy Quran and insolence in the honor of the Prophet of Islam. In view of the status of law and order, ASI Zafar Khan, Gulfam C/ 5237, Shahzad C/ 3903, Abdullah C/ 2393, Abu Saeed C/ 1320, Riaz-ul-Haq C/ 1043, Shah Riaz ASI HC/ 6831 Maqsood Ahmad, ASI 3250/ Muhammad Ahmad 5300/, Nasir 4633/C Naveed Sarwar 4690/C, at 3/05 hours on the day Chak No. 238 Gb were present that at the same time unknown persons numbering 80/70 from Abadi village, armed with sticks, slept on the roads. bags, petrol bottles etc. shouting provocative slogans came towards the UP Church Chak No. 238 GB. They started vandalizing and damaging windows, glass, furniture, etc. and created an atmosphere of fear and terror. Damaged the church building. In the meantime, more personnel arrived from the headquarters Faisalabad in case of shortage, on which they used tear gas on the angry crowd and forced the crowd to disperse and in the morning the accused were controlled. Muhammad Asad, son of Ghulam Abbas cast Malik resident of Lakar Mandi, Lahore Road,

Jaranwala, whom we saw setting fire by bottles of petrol. 10. Ishtiaq son of Manzoor Ahmad cast Malik resident of street no. 12 Rashid Park Jaranwala 11. Muhammad Idrees son of Khalid cast Arian resident of Chak no. 119 GB Jaranwala 12. Muhammad Safdar son of Maqbool Ahmad cast Bhatti resident of Chak no. 119 GB who were armed with sticks, rods, bricks and stones with our followers, we saw it came out from the scene and was arrested by the police. While the rest of the unknown accused managed to escape. On further investigation, as a result of the murderous attack of the accused, it was found that the stable of police employees No. 1- Mukhtar Ahmed HC - Zubair Inam was destroyed who were immediately sent to the hospital for treatment. Crimes by resisting 148/149/353/186/324/436/427/295 / A295 / TP7ATA Subsection i.h.g.d has been committed, therefore, according to the writing of the prosecution, this case was not sent for the purpose of Asif Ali 7062/HC. After registering the case, an inspector should be appointed to investigate the case and the editor should send the special report to the service of the authorized officer. I am present on the spot.
