Courtesy of Mr. SHO Mr. Jardanwala police station, application against 275/300 unknown accused armed with sticks, bricks, bricks, petrol bottles, etc. It is requested that I am a resident of Chak No. 238 GB of Ana and the administrator of Catholic Church Nazareth Colony Chak No. 238 Gb dated 6.08.2023 Kar Sachin Colony near Cinema Chowk City Jardanwala Desecration of Holy Quran and Glory of Prophet of Islam in the continuation of the incident of insolence, it is written that dated 16.08.2023 at around 2 p.m along with Shahroz Gulzar, son of Gulzar Masih, Bashir Masih, son of James Masih, residents of Chak No. 238 GB in Kamo Anna Jaranwala Church. There were 275/300 unknown suspects who were armed with bricks, ropes, iron rods, petrol, etc., whom we identify when they appear and can be identified with the help of other sources. The group started vandalizing and damaging the church, broke the doors and windows and poured petrol on the church and set it on fire, with which the heads of the church were from Diwali, which I do when they come out and all the other belongings and the sacred documents were burnt by all the accused, showing terror, spreading fear and causing a lot of damage to the church. We feared for our lives and did not approach. And we have also shifted to another place, now that the situation is under control, I have come for action. They have been convicted of the crime of setting fire to fire, they are claimants, action should be taken. Petition Munib Masih, son of Nazir Masih, check number 238, registration, registration, thumb mark, witness of the said police, I am present in the police station, that the above written application has been submitted by me. The crime report 436/427/295/2950/148/149/7ATA is found to be applicable, so the application is being handed over to the prosecution for the Tai case. The report should be compiled and sent to the authorized officers from the police station at 12:45 p.m Zahid Farooq SI police station city Jaranwala 21.08.2023 from the police station to write a report on
