Respected SHO, Police Station City Jaranwala, application for registration of case against 100/150 unknown accused armed with sticks, bricks, petrol, oil etc. I am a resident of Mohalla Farooq Park and an administrator of UP Church Mohalla Farooq Park on 16.08.23 Christian Colony near Cinema Chowk City Jardanwala Incident of desecration of Holy Quran and insolence towards Prophet of Islam. It is written in continuation of the tragedy of burning and encirclement due to that dated 16.08.23 at around 12/30 p.m accompanied by Waqas Bhatti son of Shar Masih, Bilal Masah son of Zulfikar Masih in Mohalla Farooq Park Jaranwala Church. I was present that 100/150 unknown accused were armed with bricks, rocks, iron rods and petrol, etc., whom I identified with the help of other sources. They came and as soon as they came, the armed group started vandalizing and damaging the church, broke the doors and windows and took out the goods, carpets, sofas, etc. from the church, poured petrol and set it on fire. All the goods were burnt. All the accused showed terror and spread fear everywhere and caused a lot of damage to the church. They managed to leave and we also moved to another place. Now that the situation is under control, I have come for action. They are guilty of breaking the church with bricks, stones and stones and setting fire to the property by pouring petrol on it. Adnan Masih, son of Siddique Masih, resident of Street No. 8, Mohalla Farooq Park Jaranwala and signature in English letters and thumb mark of the questioner. Based on the circumstances, the case of crime 148/149/295/1436/427/1295/7ATA is found to be applicable, therefore, this request is being handed over to the prosecution for the permanent case. Enrollment, investigation, investigation, investigation, in-charge, INV should be sent and a special report should be prepared and sent to the authorized officers. According to the police station, the written report on the prosecution, the preliminary information of the said offense is being prepared and the original written report along
