Courtesy of Mr. SHO of City Jaranwala police station, application for registration of case against 200/250 unknown accused armed with sticks, bricks, roadblocks, petrol etc. I am a pastor in Christian Colony dated 16.08.23 Colony near Cinema Chowk City Jaranwala due to the incident of desecration of the Holy Quran and insolence in the honor of the Prophet of Islam. At 12/30 p.m, Soloman Roshan, son of Immanwail Roshan, together with Aslam Masih, son of Anwar Masih, were present in the house adjacent to Mohalla Farooq Park, Jaranwala Church, that 200/250 unknown suspects were armed with bricks, iron rods and petrol, etc. I identify with the help of other sources and can be identified with the help of other sources. As soon as they arrived, the armed group started vandalizing and damaging the church, breaking the doors and windows and pouring gasoline on the belongings in the church They set fire to it, which burnt all the goods and sacred documents in the church. They also set fire to the goods in my house adjacent to the church and also looted some goods. There is a lot of damage to the church and my house. We did not go near for fear of our lives. I have come here, all the unknown accused have committed the crime of spreading fear everywhere by destroying the church and my house with sticks, bricks and stones and setting fire to my property by pouring petrol on the property. let's go Petition Billy Graham son of Emmanuel Roshan resident Street No. 1 FGA Church Mohalla Farooq Park Jaranwala Signature in English letters and thumb mark Questioner's testimony Police presence at the time under ASI Covered Police Station that the above written application was submitted by me See Requested Article Requested Based on the circumstances, the case of crime 1439 / 1438 / 436/4/27/2095/295/7ATA is found to be applicable, so the application is being handed over to the prosecution for the permanent case. INV should be sent as well as a special report should be prepared and sent to the authorized officers from the premises of the police station at 1:10 a.m.
