Courtesy of Mr. SHO Jaranwala, the police station has filed a case against 150/170 unknown accused, they have been beaten, bricked, petrol is being used. Hi, sir, I am a resident of Bottle etc. Mahalla Camp and I am a resident of Mission Compound Church Mahalla Camp. I am the administrator of Moor: On 16.08 Christian Colony near Cinema Chowk City Jaranwala due to the desecration of the Holy Quran and the incident of insolence in the honor of the Prophet of Islam. On 16.08.23 Bhatti son of Bashir Bhatti, Javed Masih son of Ashraf Masih residents of Mohalla Camp Jaranwala near Anjin died on 16.08.23 that 150/170 unknown accused were armed with bricks, ropes, iron rods and bottles of petrol etc. As soon as they arrived, the armed group started vandalizing and damaging the church, breaking the doors and windows and pouring gasoline on the belongings in the church. set fire to which all the goods and sacred documents in the church were burnt. All the accused showed terror and spread fear and caused a lot of damage to the church. Those who managed to escape were dispersed and we also moved to another place. Now that the situation is under control, I have come for action. Those who are guilty of breaking the church and setting fire to the property with petrol are the claimants.
