Courtesy of Mr. SHO Mr. Jaranwala police station, application for registration of case against 250/300 unknown accused armed with sticks, bricks, bricks and petrol, etc. Mr. SHO, It is requested that I am a resident of Chak No. 126 GB and I am a pastor of Presbyterian Church Chak No. 126 GB, dated 16.08.23 Sachin Colony near Cinema Chowk City Jaranwala regarding the incident of desecration of the Holy Quran and insolence in honor of the Prophet of Islam. Due to the continuation of the tragedy of burning, it is written that dated 16.08.23 at around 12:00 p.m. Aldra Sharaf, son of Aslam Masih, Shahid Kaleem father of Akram Masih were present in Jaranwala church on 26th August, 250/300 unknown persons came. They were armed with bricks, ropes, iron rods, bottles of petrol, etc., which we can identify when they appear, and with the help of other sources, they were armed with guns, which can also be identified as they came and came. The armed group started vandalizing and damaging the church, breaking the doors and windows and pouring petrol on the church equipment and set it on fire, which burnt all the equipment and sacred documents in the church. All the accused showed terrorism. He spread fear everywhere and caused a lot of damage to the church. I have come for action. All the unknown accused have committed the crime of spreading fear and destroying the church with sticks, bricks, stones and firecrackers and setting fire to the goods. Petitioner, Pastor Israel son of Peter Masih, resident of Chak No. 126, GB, Jaranwala, Signature, English letters, thumb mark, statement of the petitioner, Police, present in ASI Covered Police Station at this time, that the above written application was presented by me, see the application, the subject of the application, and the circumstances of the incident. 148/149 /1436/4/27/2095/1295 / TATA is found to be applicable to the case in hand, therefore, this form of prosecution for the permanent case is referred to the editor Jab Jaranwala English signature, thumb impression at Police Station. At this time, I

believe that after registering the case, investigating the case, the INV should be sent to the in-charge and the preliminary report should be prepared and sent to the authorized person from the police station at 1:35 p.m. 21.08.2023 by police station written report on the prosecution, preliminary information, the original written report with copy of the FIR against accusers is being sent to Mr. SHO Mr. Bakar Sarkar area police station, who is in charge, has been paid and special report is being sent to the authorized officers.
