Courtesy of Mr. SHO Mr. Jaranwala police station, application for registration of case against 225/250 unknown accused armed with sticks, bricks, bricks and petrol, etc. It is requested that I am a resident of Chak No. 240 GB and an administrator of Salvation Army Church Chak No. 240 GB. On 16.08.23 Christian Colony near Cinema Chowk City Jaranwala the incident of desecration of the Holy Quran and insolence in honor of the Prophet of Islam. It is written in the continuation of the tragedy of the burning and encirclement that dated 16.08.23 at around 1:25 p.m. along with Heera son of Faryadsi, Sunil Masih son Irshad Masih residents of 240 GB Jaranwala Church that 225/250 unknown accused were present in the church. They were armed with bricks, sticks, cans and bottles of petrol, etc., which I identified with the help of other sources and can be identified with the help of other sources. They broke the doors and windows and poured gasoline on the belongings in the church and set them on fire, fearing that all the belongings in the church were lost and the sacred documents were burnt. They spread and caused a lot of damage to the church. We did not go near for fear of life. They managed to get off and we also moved to another place. Now that the situation is under control, I have come for action. They have been convicted of the crime of breaking the church and setting fire to the property. Petitioner Siddique Masih son of Mohandar Masih resident of Chak No. 240 GB is present in the police station under the ASI cover at that time that the above written request was presented by me See the requested subject of the request and the circumstances of the incident and the crime and At this time, the application of 2950/148/149 / 1436/427/295 / 7ATA is found to be applicable in the caravan, so the application is being handed over to the man for the use of the permanent case after the case is registered and investigated. INV should be sent to the in-charge and the special report should be prepared and sent to the authorized officers from the police station at 1:50 am. The
