Due to the continuation of the tragedy of burning and encirclement, it is written that dated 16.08.23 at around 2 p.m. along with Nasir Masih son of Ghani Masih, Salim Masih son of Pyara Masih, residents of Chak 240 GB were present in Jaranwala Church that 250/300 unknown persons, armed with canisters, cans and bottles of petrol, etc., which I identified with the help of other sources and can be identified with the help of other sources. They broke the doors and windows and poured petrol on the church and set it on fire, which burnt all the church's goods and sacred pages. What is the damage? All the unknown suspects have been convicted of the crime of spreading fear by spreading terror, smashing bricks and stones with sticks, destroying the church with sticks and sprinkling petrol on the property and setting it on fire. Afzal Masih, son of Mukhtar Masih, residence, check number 240 GB, signature in English letters and mark, the said action is present, the police are present. The requested article is related to the application and circumstances, so the application is hereby found to be applicable. 7ATA/436/427/295/295A/148/149 The criminal case should be handed over to the Public Prosecutor's Office for processing.
