It is requested that I, am a resident of Asad Town Chak No. 126 GB and administrator of Salvation Army Church Asad Town Chak No. 126 GB. It is stated that dated 16.08.2023 in the continuation of the tragedy of arson at Christian Colony near Cinema Chowk City Jaranwala due to desecration of the Holy Quran and insolence in the honor of the Prophet of Islam, it is written that Dated 16.08.2023 at around 1/30 in p.m., along with Dilwar Mash son of Nazir Masih, Kashif Masih son of Mukhtar Masih residents of Asad Town Chak No. 126 GB Jaranwala were present in the church that 150/200 unknown persons armed with bricks, iron rods, oil and bottles petrol etc. They were armed with whom I identified with the help of other sources and they can be identified with the help of other sources. Pouring petrol on the existing equipment and setting it on fire, with which all the equipment and sacred documents in the church were burnt. They came and dispersed the armed group who managed to escape and we also moved to another place. Now that the situation is under control, I have come for action. They are guilty of breaking the church with bricks, stones and stones and setting fire to the property by pouring petrol on it. Petitioner Habib Masih son of Lal Masih resident Asad Town Chak No. 126 GB thumb impression of questioner The said action Police are present in the ASI Covered Police Station at that time that the above written request was presented by me. Crime 148/149/295/1436/427/1295/TATA is found to be applicable, so the application is being handed over to the prosecution for permanent prosecution after registration, investigation, prosecution, external charge and INV, sent to the trial court as well.
