Respected SHO police station City Jaranwala Application for registration of case against 250/275 unknown persons armed with sticks, bricks, stones and petrol, etc., Sir! I am a resident of Chak No. 124 GB and I am a pastor of KGM Church Additional Population Chak No. 126 GB that the incident on 16.08.2023 Cinema Chowk, Christian Colony Jaranwala, due to this incident of desecration of the Holy Quran and insolence in the glory of Islam, it is written in the continuation of the tragedy of destruction happened on 16.08.2023 at around 11:30 in a.m, I was present in the church with Rafiq Masih son of Sadeeq Masih, Lal Masih son of Soodagar Masih resident of Chak No. 126 GB, that 250/275 people forcefully entered in the church. The known suspects were armed with bricks, mortars, talons, etc., which are identified by the elders when they come forward and can be identified with the help of other sources. They started breaking the doors and windows and set fire to the equipment in the church by pouring petrol, which burnt all the equipment and sacred documents in the church. What happened? We did not go near for fear of our lives. The police came to the spot and dispersed the armed group who managed to escape and we also shifted to another place. Now that the situation was under control, I have come for action. They have committed the crime of spreading terror by destroying the church with bricks, stones and mortars and setting the property on fire by spreading the fear. After preparing the preliminary

report, the officers were arrested from the premises of the police station at 2:45 am in Zafar Iqbal ASI police station city Jaranwala. 21.08.2023 Written report on the prosecution as received from the police station, preliminary information, the original written report is compiled and used with the copy of the FIR against Atish by the deputy editor, rear-in-charge INV Mr. SHO Sahib is in Bakar Sarkar area police station, to whom the case is reported. A preliminary report has been prepared and is being sent to the authorized officers.
