Respected Mr. SHO City Police Station Jaranwala Application for registration case against 150/175 unknown accused armed with sticks, bricks, petrol, oil etc. I am the pastor of Church of Asad Town Chak No. 26 GB dated 16.08.2023 in the continuation of the tragedy of burning and encirclement due to the incident of desecration of the Holy Quran and insolence in the honor of the Prophet of Islam at Jaranwala of Christian Colony near Cinema Chowk. Dated 16.08.2023 at around 12/30 in pm along with Buta Masih son of Khushiya Masih, Samson Masih son of Bota Masih residents of Asad Town 26 1 GB Jaranwala were present in the church that 150/175 unknown accused hurled bricks, stones, iron rods, oil, petrol. They were armed with weapons, etc., whom I identified with the help of other sources and could be identified with the help of other sources. And they poured gasoline on the equipment in the church and set it on fire, with which all the equipment and sacred documents in the church were burnt. came to the spot and dispersed the armed group who managed to escape and we also moved to another place. They have been convicted of the crime of smashing the church with sticks, bricks, stones and mortars and setting fire to the property by pouring petrol on it. Petitioner Shahzad Umar Masih son of Younis Masih resident of Essa Nagri Jaranwala Signature in English letters and thumbprint Police are present in the police station at this time that the above written application has been submitted by me See the application Subject and circumstances Head of events Criminal case 148/149/295/1436/27/1295/ATA is found to be applicable, so the application is being handed over to the public prosecutor for a permanent case.
