Request That I am a resident of Chak No. 61 GB Additional Population and an administrator of New Apostolic Church Chak No. 61 GB dated 16.08.23 Christian Colony near Cinema Chowk City Jaranwala desecration of Holy Quran and Glory of Prophet of Islam Due to the incident, it is written in the continuation of the tragedy of destruction that dated 16.08.23 of 16 at around 12/45 p.m. I was with 1- Patras Masih son of Puran Masih 61 GB 2- Rashid Masih son of Hameed Masih nation Christ resident of Chak No. 61 GB present in Jaranwala Church that 150/100 unknown suspects were armed with bricks, iron rods, and bottles of petrol, etc., whom we identify when they come forward. It can also be identified with the help of the sources. As soon as they arrived, the armed group started vandalizing and damaging the church. They put it on fire and burnt the sacred documents and other items. If we dispersed the armed group who managed to escape and we also moved to another place, now after the situation is under control, I have come for action. Everyone has been guilty of spreading this crime by breaking the church with bricks, stones and stones and setting fire to the property.
